AB 33 (Aguiar-Curry)	Autonomous Vehicles (AV)	Prohibits delivery of commercial goods to a residence or business for use or retail sale by an autonomous vehicle operating without a human operator.	A.Trans, 3/24 Not set yet.	Oppose - based on present restrictions and definitions of commercial goods and uses.
AB 259 (B. Rubio)	Local Agency Teleconference	Extends the authority indefinitely for local teleconference for open meetings.	A.Local Gov., Not set yet.	Support
AB 891 (Zbur)	Quick-Build Pilot	Sets up Quick-Build pilot projects within Caltrans maintenance program for 6 projects on state highway system.	A.Trans. Set for 4/7	Monitor - Recommend seeking other sources of funding for the 6 pilots, such as SHOPP-funded ATP projects or ATP program. The term “quick-build project” means an interim capital infrastructure project that requires minor construction activities but is built with durable, low-to moderate-cost materials <i>within the state maintenance program</i>
AB 939 (Schultz)	Transportation Bond Act	Authorizes a \$20,000,000,000 State Bond Act to finance transit and passenger rail improvements, local streets and roads and active transportation projects, zero-emission vehicle investments among other items.	A.Trans Not set yet	Monitor.
AB 1070 (Ward)	Transit Governing Boards	Would add nonvoting members from transit system users (1) and affiliated labor organizations (1) to each transit district.	Asm. Local Gov. Not set yet	Monitor. The present use of elected/appointed to transit boards provides adequate access to the public.

				This bill would also require transit district board members to demonstrate, through evidence or attestation recorded by the clerk of the board, personal use of the transit system for at least one hour or four trips during the month for which the member seeks compensation.
AB 1421 (Wilson)	Road Charge TAC extension	The bill will become the focus of policy discussion and debate over Road User Charge this year.	A.Trans Not set yet	Monitor.
SB 63 (Wiener)	Funding for SF Bay Area	Spot bill for now, the bill's intent is to develop a fund source for Bay Area Transit systems.	S. Rules Not set	Work with Author.
SB 71 (Wiener)	Extends current CEQA exemptions indefinitely.	CEQA exemptions for transit and non-motorized transport systems would have relief from state environmental laws.	S. Trans. Referred, not set yet	Support. This authority is key to delivery of transit projects.
SB 480 (Archuleta)	Autonomous Vehicles (AVs)	Requires "marker lights" to be displayed ON when AV system is engaged within a vehicle.	S. Trans, 3/25	Monitor
SB 511 (Grayson)	Autonomous Vehicles (Avs)	Spot bill to establish "future guiderails" for use of AVs in public.	S. Rules Not set yet	Monitor.
SB 572 (Gonzalez)	Autonomous Vehicles (Avs): consumer notices	Requires a dealer/manufacturer that sells any vehicle that is equipped with a partial driving automation feature to provide the buyer with a consumer notice that describes the functions and limitations of those features	S. Rules Not set yet	Monitor.
