# MASTER COOPERATIVE AGREEMENT NO. 12.C.01 BETWEEN THE CONTRA COSTA TRANSPORTATION AUTHORITY AND

#### THE CITY OF PLEASANT HILL

This **AMENDMENT No. 1** ("Amendment") is made and entered into as of May 17, 2023, by and between the CONTRA COSTA TRANSPORTATION AUTHORITY ("Authority") and the CITY OF PLEASANT HILL ("City"). The City and Authority may be referenced hereinafter as the Parties, or each as a Party.

#### **RECITALS**

- A. The Parties entered into Master Cooperative Agreement No. 12.C.01 dated September 21, 2011 ("Agreement") for the City to define a framework for the Parties to work cooperatively in developing transportation improvements using the City's allocation of Measure J funds for Transportation for Livable Communities Program 12, known as CC-TLC-12 funds (Measure J).
- B. City intends to carry out a project that will be funded in part by the Pedestrian, Bicycle, and Trail Facilities Program 13 (CC-PBTF-13), the Program after award which has requirements and policies that are mostly equivalent to those applicable to the CC-TLC-12 funds. The Parties, however, do not currently have an agreement in place regarding the CC-PBTF-13 funds. Accordingly, the Parties desire to amend the Agreement so as to apply the relevant policies from the Agreement to the CC-PBTF-13 funds.

#### **AMENDMENT**

- (1) The Parties agree that all provisions of the Agreement, as amended hereby, shall apply to CC-PBTF-13 funds in addition to their current application to CC-TLC-12 funds.
- (2) City agrees that any project programmed and appropriated by the Contra Costa Transportation Authority for the receipt of CC-PBTF-13 funds will be designed, constructed, delivered, and implemented in general accordance with the Agreement as amended hereby.
- (3) Exhibit A as attached hereto shall apply to all projects funded through Program CC-PBTF-13 funds in lieu of Exhibit A as attached to the Agreement and applicable to CC-TLC-12 funds.
- (4) Exhibits B, C, D-1, and D-2, and related attachments are amended to be applicable to CC-PBTF-13-funds and subject to CC-TLC-12 requirements.

(5)	Except as expressly modified in this Amendment, all other terms, covenants, and	
conditions of the Agreement shall remain in full force and effect and are hereby ratified and		
confirmed.
