The legislature is approaching May 12 when policy committees will have completed the analyses of the bills introduce thus far in the 2023-24 Session. Legislative activity is turning toward the Budget as the Governor is expected to introduce the state's projected major revenue and workload adjustments to the 2023-24 State Budget Act by May 10, at which time the Budget Subcommittees will undertake their reviews of new proposal and proposals held over from earlier.
